PG&E is planning to conduct gas pipeline safety testing along 7th Avenue starting in late June.

## FROM THE HARBORMASTER

For many years, the Port District has utilized a non-emergency cell phone number (212-4261) as a way for slip renters, concessionaires, and visitors to contact Harbor Patrol deputies for routine matters, to request after-hours assistance, or to report suspicious activities within the harbor.

For many, this non-emergency number has become a heavily used direct form of communication with Harbor Patrol. In an effort to increase safety, improve Harbor Patrol's response times to both emergency and non-emergency situations, and gather information about crimes occurring within the harbor, the Port District will discontinue the use of this non-emergency contact number on July 1, 2015. **To report all incidents and emergencies, immediately dial 9-1-1. For non-urgent matters, call (831) 471-1131.**
